Report of the Consultative Group to the President of the Human Rights Council relating to the Special Procedures mandate holders to be appointed at the 16th session of the Human Rights Council

I. Background

1. Further to Human Rights Council resolution 5/1, a Consultative Group was established to propose to the President, at least one month before the beginning of the session in which the Council would consider the selection of mandate holders, a list of candidates who possess the highest qualifications for the mandates in question and meet the general criteria and particular requirements. The Members of the Consultative Group serving in their personal capacity are H.E. Mr. Gopinathan ACHAMKULANGARE, Permanent Representative of India; H.E. Ms. Maria CIOBANU, Permanent Representative of Romania; H.E. Mr. Hannu HIMANEN, Permanent Representative of Finland, H.E. Mr. Darlington MWAPE, Permanent Representative of Zambia and H.E. Mr. Alberto NAVARRO BRIN, Permanent Representative of Panama.

II. Process

- 2. The Consultative Group held two formal meetings on 5 and 12 January 2011 to consider candidates for the six vacancies of mandate holders to be appointed at the sixteenth session of the Council. Based on a decision of the Consultative Group, H.E. Mr. Hannu Himanen chaired these two meetings.
- 3. The Consultative Group was informed that a total of 244 candidates were now on the public list (see annex I).
- 4. The members of the Consultative Group took into consideration the technical and objective requirements as stipulated in the annex to Council resolution 5/1, in paragraphs 39, 40, 41, 44, 45, 46, 48 and 50, as well as in Council decision 6/102. The Group received a letter from the Chair of the Coordination Committee of Special Procedures regarding the vacancies to be filled. The Group also paid due attention to gender balance in the consideration of candidates.
- 5. In accordance with established practice, it was decided that each member of the Consultative Group would suggest a number of candidates based on the candidates' qualifications, relevant experience, expertise, independence, impartiality, personal integrity and objectivity, in compliance with relevant provisions of Council resolution 5/1 and decision 6/102.
- 6. A total of 38 candidates were given further consideration by the Group at the second stage of the selection. The list of candidates is attached for information (see annex II).

III. Candidates proposed by the Consultative Group to the President

1. Special Rapporteur on the rights to freedom of peaceful assembly and of association

Concerning the recommendation for the mandate of the Special Rapporteur on the rights to freedom of peaceful assembly and of association, established by Human Rights Council resolution 15/21, there was strong support within the Consultative Group for Mr. **Maina KIAI** (Kenya).

Mr. Kiai is currently the Executive Director of the International Council on Human Rights Policy in Geneva. He has served as the Chairperson of the Kenya National Commission on Human Rights from 2003 to 2008 and in this capacity has provided leadership to the Commission and the Government on ways of preventing, protecting and promoting human rights and good governance in Kenya. In the area of freedom of peaceful assembly and of association, the candidate has worked as the Strategic Advisor to the Movement for Political Accountability which aims to improve the relevant political situation in Kenya. He also has served as the Africa Director of the International Human Rights Law Group (now Global Rights) and the Director of Africa Program at Amnesty International.

There was general support within the Consultative Group for Mr. Serghei OSTAF (Republic of Moldova).

Mr. Ostaf is a member of Panel of Experts of the Office for Democratic Institutions and Human Rights of OSCE (2006-2012) with the mandate to elaborate the Guidelines on Freedom of Assembly, to conduct legal review of draft legal law of certain countries on freedom of assembly and to undertake other related functions. He is the author of several publications and research papers related to freedom of assembly and association, including on such topics as the analysis and expertise of the Moldovan draft law on mass-demonstration and the freedom of assemblies in electoral context.

In addition, Ms. Mariclaire ACOSTA URQUIDI (Mexico), Mr. Bernard DUHAIME (Canada) and Ms. Irene KHAN (Bangladesh), listed in alphabetic order, were also identified as qualified candidates with the required expertise and experience, who also enjoyed some support of the Group.

Ms. Acosta Urquidi has served as the Special Advisor to the Secretary-General of the Organization of American States for Civil Society Affairs and the President of the Mexican Commission for the Defense and Promotion of Human Rights. She is a member of the Steering Committee of the World Democracy Movement in Washington DC, USA.

Mr. Duhaime is an Associate Professor of Law at the Quebec University at Montreal, Canada and the Director of the University's International Clinic for the Defense of Human Rights. He has served as the Staff Attorney at the Inter-American Commission on Human Rights.

Ms. Khan has served as the Secretary-General of Amnesty International and in this capacity has campaigned for human rights promotion and protection in various areas. She is the recipient of the 2006 City of Sydney Peace Prize and the 2006 Athens Bar Association Award.

Summaries of the candidates' resumes are included in the public list of candidates.

2. Working Group on the issue of discrimination against women in law and in practice

Concerning the recommendation for members of the Working Group on the issue of discrimination against women in law and in practice, established by Human Rights Council resolution 15/23, the recommendation of the Consultative Group is as follows:

Member from African States

There was strong support within the Consultative Group for Ms. Emna AOUIJ (Tunisia).

Ms. Aouij has been a member of the Committee on the Elimination of Discrimination against Women (CEDAW) from 1990-2002 and member of the Tunisian delegation to the 1995 World Conference on Women in Beijing. She also has been the Independent Expert of the Commission on Human Rights on the situation of human rights in Chad and the Chairperson of the steering committee for the modernization of the judicial system of Tunisia. Ms. Aouij has served as an advisor to the Supreme Court of Tunisia and was the first President of the Cour des Comptes of Tunisia from 1998 to 2000.

In addition, there was general support within the Consultative Group for Ms. Hynd AYOUBI IDRISSI (Morocco) and Ms. Azza SOLIMAN (Egypt), listed in alphabetical order.

Ms. Hynd AYOUBI IDRISSI is professor of law in the Faculty of Law in Rabat, Morocco. She has worked in the Ministry of Human Rights from 1998 to 2004 and participated in a number of meetings and conferences on human rights at international fora including the CEDAW, CRC, CAT and CERD. She also provided support to the process of the harmonization of national legislation with international human rights instruments ratified by Morocco, in particular the CRC and CEDAW.

Ms. Soliman is the General Manager of the Center for Egyptian Women's Legal Assistance and has worked with UNIFEM Egypt in preparing a manual on women's human rights in the Arab region. She has conducted research on honour crimes and the social and economic cost of divorce in Egypt. Ms. Soliman has developed training projects on topics of human rights approaches, discriminatory family laws and other gender issues.

Member from Asian States

There was unanimous support within the Consultative Group for Ms. Kamala CHANDRAKIRANA (Indonesia).

Ms. Chandrakirana has worked as the Chairperson and Secretary-General for Indonesia's National Commission on Violence Against Women and in such capacities has submitted reports and briefs to several human rights treaty bodies. She has been appointed as member of Asia-Pacific Regional Advisory Group on Women, Peace and Security, established by the United Nations Regional Coordination Mechanism Thematic Working Group on Gender Equality and the Empowerment of Women. Ms. Chandrakirana is also a member of the Southeast Asia Women's Caucus on ASEAN, a network of women's rights advocates collaborating to secure the advancement of women's human rights through ASEAN's new human rights architecture.

In addition, there was general support within the Consultative Group for Ms. **Zarizana ABDUL AZIZ** (Malaysia) and Ms. **Shanthi DAIRIAM** (Malaysia), listed in alphabetical order.

Ms. Abdul Aziz has been the Co-Chairperson of the Human Rights Committee of the Malaysian Bar Council and has worked as a consultant for the United Nations Division for the Advancement of Women. She has undertaken research on developing due diligence standards and indicators on violence against women. Ms. Abdul Aziz has also been the Council member and Honorary Director of the non-governmental organization Women Living under Muslim Laws.

Ms. Dairiam is the founder of the International Women's Rights Action Watch-Asia Pacific and has been a CEDAW member from 2005 to 2008. She has been commissioned by the OSCE to review the draft Gender Equality Law in Tajikistan in 2003. Ms. Dairiam has worked with various United Nations bodies with specific institutional mandates on women, such as the United Nations Development Fund for Women and the Division for the Advancement of Women.

Member from Eastern European States

There was general support within the Consultative Group for Ms. **Eleonora ZIELINSKA** (Poland)

Ms. Zielinska is a law professor at the Warsaw University, Poland and has served as a government representative at the 1995 World Conference on Women in Beijing and a member of the Polish delegation to the United Nations Commission on the Status of Women from 1995 to 1997. She is co-author of the draft law on reproductive rights and on equal status of women and men in Poland. In 2001, Ms. Zielinska received the Polish Laureate of Women of Europe Award.

In addition, Ms. Elena DINGU-KYRKLUND (Sweden/Romania) also enjoyed some support from the Consultative Group

Ms. Dingu-Kyrklund has been a member of the Romanian Association of International Law and International Relations. She has worked as a member of the Swedish CEDAW Committee for the writing of a thematic report on discrimination against women in law and in practice.

Members from Latin American and Caribbean States

There was strong support within the Consultative Group for Ms. Mercedes BARQUET (Mexico).

Ms. Barquet is a professor with teaching experience in women's rights and gender relations. In 1993, she has been the Mexican representative to the Seminar for Senior Officers of National Machineries for the Advancement of Women, Tokyo, Japan and has been Mexico's coordinator of social topics for the 1995 World Conference on Women in Beijing and a member of the Mexican delegation to the United Nations Commission on the Status of Women in 2005. From 2001 to 2006 Ms. Barquet has served as the Advisor and member of the Board of National Institute for Women, Mexico.

In addition, there was general support within the Consultative Group for Ms. Haydee Mendez Illueca de ESPINO (Panama) and Ms. Alda FACIO MONTEJO (Costa Rica/United States of America), listed in alphabetical order.

Ms. Espino has a Ph.D degree with the specialization in gender and criminal law and has published on the topic of women's rights. She has worked with the Ombudsman of Panama as the drafter of a bill for the prevention and sanction of violence against women.

Ms. Facio Montejo has been the Director of Women, Justice and Gender Programme of the United Nations Latin American Institute for Crime Prevention since 1991. She has worked with International Women's Rights Action Watch Asia Pacific in relation to CEDAW.

Member from Western European and other States

There was general support within the Consultative Group for Ms. Frances RADAY (Israel/United Kingdom).

Ms. Raday is the Director of the Research Institute for Integration of International Law in Israel and was a CEDAW member from 2000 to 2003. She has published widely on status of women and on CEDAW related legal and social issues. Ms. Raday has also served as the Chair of the Committee for Advancement of Women at the Israel Bar Association and as the Chair of the Israeli Association of Feminist and Gender Studies.

Mr. Andrew BYRNES (Australia) was also identified as a qualified candidate who enjoyed some support within the Consultative Group.

Mr. Byrnes is a professor of law at the University of New South Wales, Australia. He is a joint author of commentaries on the Convention on the Elimination of All

Forms of Discrimination against Women and was a consultant to the Division for the Advancement of Women. Mr. Byrnes has also served on the Asian Development Bank's External Forum on Gender and Development.

In addition, there was some support within the Consultative Group for Ms. Fanny BENEDETTI (France) and Ms. Regan RALPH (United States of America), listed in alphabetical order.

Ms. Benedetti is an expert consultant on women and children rights with the French Ministry of Foreign Affairs. She has headed the national delegation at the drafting committee of the Council of Europe on violence against women and domestic violence since 2008.

Ms. Ralph is the founder and Executive Director of the Fund for Global Human Rights, USA. She has worked at Human Rights Watch, USA on women's rights and has taught at Georgetown University on women's international human rights from 1993 to 2003.
